

## **“Guest Splasher Sweepstakes” Official Rules**

**No purchase or payment of any kind is necessary to enter or win. A purchase will not increase your chances of winning.**

### **1. Sponsor**

The “Guest Splasher Sweepstakes” (“Sweepstakes”) is sponsored by Tower Federal Credit Union (“Tower” or “Sponsor”), 7901 Sandy Spring Road, Laurel, MD 20707.

This Sweepstakes is not sponsored, endorsed, administered by, or associated with, Facebook, or any other social media platform. This Sweepstakes is in no way sponsored by any of the MLB Entities. ### **2. Eligibility**

The Sweepstakes is open only to legal residents of Maryland, Virginia, Pennsylvania, and Washington, D.C. who are eighteen (18) years of age or older at the time of entry.

Employees, officers, and directors of Sponsor, the MLB Entities and their immediate family members or household members are not eligible. “MLB Entities” means the Office of the Commissioner of Baseball (“BOC”), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. (“MLB”), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (“Clubs”), each of their parent, subsidiary, affiliated, and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees, and agents of the foregoing entities.

### **3. Sweepstakes Period**

The Sweepstakes begins at 12:00 a.m. Eastern Time (ET) on June 8, 2026 and ends at 11:59 p.m. ET on August 11, 2026 (“Sweepstakes Period”).

### **4. How to Enter**

Limit one (1) total entry per person per drawing regardless of method of entry, unless otherwise specified by Sponsor.

Entries generated by script, macro, bot, or other automated means are void.

Mail-in entries for Grand Prize Drawing #1 must be postmarked by June 14, 2026 and received by June 17, 2026 to be eligible for the June 27 Guest Splasher Experience drawing.

Mail-in entries for Grand Prize Drawing #2 must be postmarked by August 7, 2026 and received by August 10, 2026 to be eligible for the August 20 Guest Splasher Experience drawing.

Eligible non-winning entries from Grand Prize Drawing #1 will automatically remain eligible for Grand Prize Drawing #2.

## **5. Prize Details**

### **Grand Prize #1**

- Four (4) tickets for winner and three (3) guests in the Tower Bird Bath area or comparable seating location for the June 27, 2026 Baltimore Orioles home game, as determined by Sponsor in its sole discretion
- The opportunity for winner only to participate as Guest Splasher during the game.

### **Grand Prize #2**

- Four (4) tickets for winner and three (3) guests in the Tower Bird Bath area or comparable seating location for the August 20, 2026 Baltimore Orioles home game, as determined by Sponsor in its sole discretion
- The opportunity for winner only to participate as Guest Splasher during the game.

Approximate Retail Value ("ARV") of each prize: \$600.

Prizes are non-transferable and may not be redeemed for cash. Sponsor reserves the right to substitute a prize of equal or greater value if necessary.

Transportation, parking, lodging, food, beverages, and any other expenses not specifically listed are the sole responsibility of the winner and guests.

Major League Baseball game/event/exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club and may be subject to change. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the license granted by the game/event/exhibition ticket.

## **6. Winner Selection and Notification**

Sponsor or Sponsor's designated representative shall conduct two (2) separate random prize drawings during the Sweepstakes Period as follows:

Eligible entries will be entered into a random drawing for the opportunity to participate as Guest Splasher during the Saturday, June 27, 2026 Baltimore Orioles home game and receive four (4) tickets in the Tower Bird Bath area or comparable seating location, as determined by Sponsor in its sole discretion.

One (1) winner will be selected in a random drawing on or about June 19, 2026 and notified within approximately forty-eight (48) hours of selection.

### **Grand Prize Drawing #2 – August 20 Guest Splasher Experience**

Eligible entries will be entered into a random drawing for the opportunity to participate as Guest Splasher during the Thursday, August 20, 2026 Baltimore Orioles home game and receive four (4) tickets in the Tower Bird Bath area or comparable seating location, as determined by Sponsor in its sole discretion.

Eligible non-winning entries from Grand Prize Drawing #1 will automatically carry over and remain eligible for Grand Prize Drawing #2.

One (1) winner will be selected in a random drawing on or about August 12, 2026 and notified within approximately forty-eight (48) hours of selection.

A winner selected for Grand Prize Drawing #1 is not eligible to win Grand Prize Drawing #2.

Odds of winning depend on the number of eligible entries received.

Potential winners will be notified using the contact information provided at entry. If a potential winner cannot be contacted, fails to respond within forty-eight (48) hours, is found to be ineligible, or fails to timely complete required documents, Sponsor may select an alternate winner.

## **7. Guest Splasher Participation Conditions**

Winners acknowledge that the Guest Splasher experience is an in-game entertainment activation that may involve public introduction during the game, participation in Bird Bath splash moments, interaction with Mr. Splash and stadium entertainment staff, on-camera appearances and crowd visibility, and water exposure and wet conditions.

Winner and guest may be required to sign publicity, liability, and/or appearance release documents prior to participation.

The prizes are currently anticipated to be fulfilled in connection with the Baltimore Orioles home games scheduled for **June 27, 2026 and August 20, 2026**; however, the game dates are subject to change.

Winners must be available for the assigned game date or prize may be forfeited and awarded to an alternate winner. Sponsor reserves the right to reschedule the prize, substitute a prize (or portion thereof) of equal or greater value, or modify the prize as necessary.

The Guest Splasher experience is subject to change, modification, or cancellation at the discretion of the Baltimore Orioles or stadium operations. Sponsor does not guarantee the availability of this portion of the prize.

The prize is non-transferable and may not be sold, assigned, or redeemed for cash. No substitution or cash equivalent is permitted, except at Sponsor's sole discretion.

## **8. Documentation / Event Requirements**

Winner must provide requested information for prize fulfillment, including advance submission of full legal name as required by stadium security policies.

Winner must present valid government-issued identification at check-in.

Failure to comply may result in forfeiture of the prize.

## **9. Publicity and Content Use**

By entering, participants grant Sponsor and its designees the right to use their name, likeness, city/state of residence, and any submitted text, photos, or other content for advertising, promotional, and marketing purposes in any media, worldwide, without additional compensation, unless prohibited by law.
